

For the past 35 years, our goal at Lovelane has been to provide high-quality therapeutic horseback riding to help children with special needs achieve therapeutic gains in an environment that is both supportive and fun.

With a solid, committed core staff team that includes more certified instructors than last year, and an excellent corps of per diem instructors, we have been able to increase the number of children we serve through both our mounted and unmounted programs. We have also added a new, exciting partnership, which has allowed us to utilize our resources in a way that expands both our reach and our impact.

This year the costs associated with caring for and feeding our herd of therapy horses has continued to go up. And as we reach our 20th year at this location, we know we will need to focus on maintaining and improving our facility in order to continue to achieve our mission safely and effectively.

Serves 45 students each semester in small groups of 4-6, integrating children both with and without special needs

CARROT CLUB // ages 3-6

fosters positive peer interactions that support social language development and social skill building; helps students develop strategies for cooperative play, self-regulation, and following a group plan; builds self-esteem and confidence; improves students' conversational skills, including turn-taking, topic maintenance, eye contact, and body language.

BARN BUDDIES // ages 5+

promotes physical, emotional, and social growth of each child; students work as a team to take care of Lovelane's horses.

HORSE CARE ACADEMY // teens

builds confidence and functional life skills, including time management, prioritizing tasks and responsibilities, managing and working with a team, and communicating with peers and supervisors; empowers participants and readies students to take on the "real world."

FIND YOUR STRIDE // young adults



The 2023 Susan McDaniel Run for Lovelane took place in June on a beautiful sunny day! It was a great success thanks to all our participants and families! Three-hundred and seventy-six adults and children ran or walked the 5K, 1 Mile, and ½ Mile Kids' Fun Run to raise \$25,000 for the Susan McDaniel Tuition Assistance Fund at Lovelane.

SUSAN MCDANIEL TUITION ASSISTANCE FUND

Susan McDaniel, an athlete, actress, and equestrian, was a student at Lovelane throughout her two-year battle with cancer. Susan passed away in 2004 at the age of 10. The Run for Lovelane, established in 1996, was dedicated in Susan's memory in 2005. At the same time, the Susan McDaniel Tuition Assistance Fund was created. The intended purpose of this non-restricted fund is to support families who are unable to afford Lovelane's lesson price of \$136 weekly. Lovelane accepts children off the waitlist based on next availability, not the family's ability to pay. Once in the program, families may apply for tuition assistance. Forty percent of Lovelane families receive tuition assistance totaling \$65,000 annually through the Susan McDaniel Tuition Assistance Fund.

Find Your Stride

Find Your Stride (FYS) is an unmounted social skill-building program for young adults at Lovelane.

This group is facilitated by a speech-language pathologist who specializes in social cognition. The facilitator utilizes the horses and the welcoming barn environment to create opportunities for practicing and building on social communication skills.

Find Your Stride helps the participants increase social and situational awareness, develop strategies for successful social interactions, build self-esteem and confidence, and practice self-advocacy. Students also work on improving their conversational skills, including turn-taking, topic maintenance, eye-contact, and body language, and developing independent living and occupational skills.

As Find Your Stride has progressed, the participants have embraced the idea of being ambassadors of Lovelane.

- As you walk through the barn you will be reminded of Lovelane's core values through the display that the FYS group created.
- FYS helps with planting flowers at different seasons to help make Lovelane even more beautiful and welcoming.
- The FYS crew is at the center of a new Lovleane tradition, The Lovelane Halloween Event, where 40 Lovelane families enjoy the opportunity to trick-or-treat in a safe, wheelchair and walker friendly environment. They enjoy trick-or-treating at every horse's stall and play fun games in the indoor arena.
- At the annual Lovelane Horse Show, the FYS crew was excited to jump in and help coordinate and run the sales table with baked goods, Lovelane merch and hand-crafted items that they made themselves.

The FYS crew created an informative video about Lovelane that can be found on the Lovelane website and is used in Lovelane's parent education activities. Future ideas include spreading the love of Lovelane to the local community. In February, we plan to send homemade Valentine's to local nursing homes.

City to Saddle

This July, Lovelane hosted six students from the Boys and Girls Clubs of Metrowest Framingham Clubhouse.

These students participated in a Horsemanship Workshop, visiting the barn for three hours each day for a week to learn about the horses, take care of them, and ride. Our instructors encouraged the students to ask questions and find their voices, and focused on helping them gain confidence in self-advocacy, self-expression, and empathy towards themselves and others. The students, who had never ridden before, rode independently by week's end, navigating an obstacle course on their horses, having honed their skills of steering, posting, and trotting. The students made strong connections with our horses. From the first anticipatory moments of welcome to the final tearful goodbyes, the week was filled with joy and learning for everyone involved. In reflecting on the week, one instructor shared: "It was clearly evident that the power of horses was so significant to each of these children and I felt and hope that they will carry this experience throughout their lives. I certainly will."
