We have also worked hard to expand our reach in other ways. Our social media outreach is up. Participants in our social skill-building program for young adults, Find Your Stride, have continued to serve as ambassadors for Lovelane, providing tours to local community groups. We continue to hear from people new to us that they "saw us on the news!" And we've been fortunate this year to have experienced a significant increase in new donors and event sponsors.

Meet Danielle

Danielle was born with an unspecified brain injury. As a child, she had difficulty controlling her body. She would collapse to the floor without warning or run without stopping until she hit a wall. Danielle's first lesson at Lovelane her parents watched through tears as she sat upright on a horse, controlling its movement when she could hardly control her own. She was flanked on either side by a volunteer as her instructor, took her through the lesson. It was magic.


As she got older, Danielle defended fiercely against her disability. She did not want to be different. She looked on as her peers participated in a variety of sports that she did not have the skills to join. Horseback riding became Danielle's superpower. She owned it as her sport, and it became something that she could teach others about. Danielle went on to become a gold medal recipient in the Special Olympics!



Meet Jack

By the young age of 2, Jack, born with cardiomyopathy and a rare congenital eye disease called Peters Anomaly, has faced a heart transplant, multiple eye surgeries, autism and global developmental delays. Challenged by repetitive behaviors, emotional dysregulation, and difficulty following instructions, staying focused, and communicating his thoughts and feelings to others, Jack struggles with social integration at school and often plays alone.

On horseback, Jack is calm, comfortable, focused and happy. Over time, the natural movement of the horse has helped him become stronger and more balanced. In addition to therapeutic gains, Lovelane has helped Jack improve his attention span, regulate his behavior and emotions, and develop his language, comprehension, and social and communication skills.



Meet Ori

Ori is an inquisitive 14-year-old with Down Syndrome (Trisomy 21). He began taking horseback riding lessons during the pandemic, which was a challenging time for someone like our son, who has such an engaging and interactive personality. Lovelane played a crucial role in channeling Ori's energy and helping him to grow in so many ways. Physically, Ori has become stronger and noticeably more graceful, not falling or tripping as often when he runs or walks. In addition, having learned more effective non-verbal communication from working with horses, Ori has become better able to regulate himself and increasingly self-aware. These gains have transferred nicely to human relationships.

Ori has surpassed his goals and has accomplished so much during his time at Lovelane.



Meet Wenbo


Wenbo was born with a very rare genetic disease, is completely non-verbal with severe epilepsy and has recently faced open skull brain surgery. On horseback, he is completely engaged and comfortable on a horse. Wenbo is his best self at Lovelane.

It has been ten years since Wenbo started riding at Lovelane. Still, his love for riding, the physical improvement we continue to witness in Wenbo and the connection with the horses he rides, his instructors, and his volunteers remain unchanged.

Benefiting the Susan McDaniel Tuition Assistance Program

The 2024 Susan McDaniel Run for Lovelane took place on Sunday, June 9.

Thanks to all our families and participants who braved the rain to run for Lovelane—it was a great success! The fantastic event included a 5K Run, a 1 Mile Walk, ½ Mile Kids’ Fun Run and a Diaper Dash and raised over \$30,000 for the Susan McDaniel Tuition Assistance Fund at Lovelane.

SUSAN MCDANIEL TUITION ASSISTANCE FUND

Susan McDaniel, an athlete, actress, and equestrian, was a student at Lovelane throughout her two-year battle with cancer. Susan passed away in 2004 at the age of 10. The Run for Lovelane, established in 1996, was dedicated in Susan’s memory in 2005. At the same time, the Susan McDaniel Tuition Assistance Fund was created. The intended purpose of this non-restricted fund is to support families who are unable to afford Lovelane’s lesson price of \$150 weekly. Lovelane accepts children off the waitlist based on next availability, not the family’s ability to pay. Once in the program, families may apply for tuition assistance. Forty percent of Lovelane families receive tuition assistance totaling \$65,000 annually through the Susan McDaniel Tuition Assistance Fund.




